Reminders for children returning in the fall:

****Before your child begins next year, we must have their immunization record and a letter from their pediatrician stating that they have been examined and are healthy to begin a daycare program. If your child is **4 by September 1st**, we need hearing and vision assessments as well.**

****Our policy states that CHILDREN THAT ARE 3 YEARS OLD MUST BE IN THE PROCESS OF ACTIVE POTTY TRAINING. CHILDREN ENTERING THE pre-k 4 YEAR OLD CLASSES MUST BE COMPLETELY POTTY TRAINED.**
