## Reminders for children returning in the fall:

\*\*Before your child begins next year, we **must have** their **immunization record** and a **letter from their pediatrician** stating that they have been examined and are healthy to begin a daycare program. If your child is **4 by September 1<sup>st</sup>**, we need hearing and vision assessments as well.

\*\*Our policy states that CHILDREN THAT ARE 3 YEARS OLD MUST BE IN THE PROCESS OF <u>ACTIVE</u> POTTY TRAINING. CHILDREN ENTERING THE pre-k 4 YEAR OLD CLASSES <u>MUST BE COMPLETELY POTTY TRAINED</u>.
